If this form is not emailed by the end of the next business day that you enrolled for the summer sessions in the portal, then your spot will be released.

Instructions for confirming enrollment, if not a current client:

Complete the [Registration Form](#) which will require you to enter a primary payment method for the Parent Portal and will setup a Parent Portal account. Log in to the [ParentPortal](#) (use the email address from the registration form and select forgot my password to login for the first time) and under search classes to select the summer classes you are interested in, and then enroll. Within one day, complete this form, sign it, and email it to farmschooladmissions@gmail.com, you will be auto-billed for the sessions selected in the parent portal against your primary payment method on file. If this form is not emailed by the end of the next business day that you enrolled for the summer sessions in the portal, then your spot will be released.

Policies

In addition to any policies outlined in the Family Handbook, I/we understand that the following policies will apply:

1. There is no discount, refund, or other allowance for absence, illness, vacation, holidays, school closures, inclement weather or any other reason (including changing mind or acceptance in another program).
2. All tuition for the summer is due in full at the time of signature of this document. No space will be held for any child without a signed copy of this document and full prepayment of all summer tuition.
3. Tuition for the summer is non-refundable and cannot be applied to any present or future enrollment at Good Earth Farm School.
4. School regular operational hours are Monday – Friday from 7:15 a.m. to 5:15 p.m. (with the exception of school holidays listed in the Family Handbook and any other school closures). Families picking children up after their scheduled departure of 5:15 p.m. will be charged a late fee of \$1 per minute after a 5 minute grace period, that they are late.
5. A \$30 fee will be assessed for all NSF checks or other forms of returned payments.
6. Whole Earth Farm School, LLC reserves the right to exclude any child from attendance, temporarily or permanently, under any circumstances deemed, in the sole and exclusive discretion of the School, if attendance at the School for that child interferes with the health, safety or educational development of the child or any other child(ren) or whose conduct is unsatisfactory. The School further reserves the right to deny continued enrollment, or re-enrollment, to any student if the School reasonably concludes that the actions of a parent or guardian are inconsistent or not supportive of the educational environment or are counterproductive to a positive working relationship between the School and that child's parents or guardians.
7. Meals and snacks are included in tuition. See the published weekly menu on the school blog.
