In addition to any policies outlined in the Family Handbook, I/we understand that the following policies will apply:

1. There is no discount, refund, or other allowance for absence, illness, vacation, holidays, school closures, inclement weather or any other reason.
2. Parents/guardians will be required to give a minimum of 30 days' notice to terminate enrollment. The last day of attendance/notice/tuition billing will be the last day of a full month. Ex. notice given on January 15 would mean that the Preschool Tuition Contract would be terminated effective February 28.

Notice must be submitted on the Withdrawal Notice & Schedule Change Request Form located on the school's website ([www.goodearthfarmschool.com](http://www.goodearthfarmschool.com)). Parents/guardians will be responsible for paying the tuition during the notice period even if the child does not attend school during that month.

3. School regular operational hours are Monday – Friday from 7:15 a.m. to 5:15 p.m. (with the exception of school holidays listed in the Family Handbook and any other school closures). Families picking children up after their scheduled departure (1:00 p.m. or 5:00 p.m. half day schedules, 3:30 p.m. regular schedules or 5:15 p.m. extended day schedules) will be charged a late fee of \$15 for each 15 minutes, or fraction thereof, that they are late.
4. Tuition, waitlist fees, registration fees, late payment fees, late pick-up fees and all other fees due and owing are payable directly to Good Earth Day School, LLC.

5. Tuition is due the first day of each month. If tuition is not received by the close of the second day of each month, a \$10 fee will be assessed each day beginning on the third day of the month until the account is current. Additionally, children cannot be received for care beginning the third business day of the month and until tuition is paid in full and the account is current. A family whose payment falls behind one week (five business days) will be asked to find other care for their children.

6. A \$30 fee will be assessed for all NSF checks or other forms of returned payments.

7. Good Earth Day School, LLC reserves the right to exclude any child from attendance, temporarily or permanently, under any circumstances deemed, in the sole and exclusive discretion of the School, to be interfering with the health, safety or educational development of the child or any other child(ren) or whose conduct is unsatisfactory. The School further reserves the right to deny continued enrollment, or re-enrollment, to any student if the School reasonably concluded that the actions of a parent or guardian are inconsistent or not supportive of the educational environment or are counterproductive to a positive working relationship between the School and that child's parents or guardians.
